## VOCATIONAL/TRADE/TECHNICAL SCHOOL 2025 SCHOLARSHIP APPLICATION

### **RULES OF ELIGIBILITY**

- An eligible applicant for this scholarship award might be planning to attend a community college, vocational school, trade school or other short-term training program in fields such as automotive technology, plumbing, heating, construction, welding, advanced manufacturing, cosmetology, computer repair, etc. and must meet the following qualifications:
  - a. A member of good standing with the Association for at least **three years** prior to date of application <u>and</u> hold **one of the following policies in his or her own name**: a \$1,000 minimum permanent life insurance certificate; a \$5,000 minimum term certificate; or an annuity certificate. Such membership standing shall be verified from the records of the Home Office.
  - b. Members currently in **Z-Branches** from the Polish Women's Alliance of American (PWAA) are eligible for FCSLA scholarships once the hold, in their own name, an <u>FCSLA issued</u> Policy for 3 years prior to date of scholarship application. Other Scholarship opportunities are available exclusively to **Z group members** through the PWAA Charitable and Educational Foundation. Interested members should contact the Scholarship Department directly at Scholarship@fcsla.org or call 1-800-464-4642 ext.1054.
  - c. Applicants are eligible to win only once in this award category.
  - d. Enrolled in or entering an accredited vocational or technical program in the United States. Applicant must be enrolled or planning to enroll within 6 months of the application deadline, for a minimum of **12 credit hours** in a program leading to a certificate, diploma or associate degree.
  - e. Students currently enrolled in a Bachelor or other advanced degree program are not eligible.
  - f. The Award must be used for school-related expenses (e.g., tuition, books, fees, and course or degree-related costs (like supplies and equipment required for specific classes) for the academic year for which it was awarded.
  - g. Applicants must have a high school diploma or Graduate Equivalent Degree (GED) without a bachelor's or advanced degree.

#### 2. Application requirements:

- a. Submit an official transcript of the student's high school or college grades from the most recent grading period. Applicants can also have his or her school send an official copy on his or her behalf – please indicate on the application.
- b. Submit a letter of recommendation not from a family member.
- c. An autobiographical statement of approximately 500 words containing your goals and objectives. Describe any demonstrated leadership skills. In one of the paragraphs, describe how you were involved in school activities. In another, give details of your church or community service. Was it voluntary? Mandatory?
- d. A copy of the letter of acceptance or proof of enrollment to the school named in this application.
- e. Include a **wallet-sized photo.** It must be an actual photo, a photo printed on photo paper or a .jpg attachment to an e-mail when submitting it electronically.

- f. All applications and supporting documents must be POSTMARKED or electronically received no later than Tuesday, February 11, 2025. Applications postmarked or electronically received after this date will not be considered. Materials submitted in support of the application will not be returned. Application and supporting documents may be submitted electronically as an e-mail attachment (PDF file) or fax. - 3. Seven- \$1,250 individual Vocational/Trade/Technical School Scholarships will be awarded, depending on the number of eligible applicants.
- 4. The final decision will be made by an outside committee in the education field (Judging Committee). Winners will be notified by letter in the 2<sup>nd</sup> week of May 2025. Names of winners will be published in the August issue of "Fraternally Yours." Award checks will be issued on or about July 1st in the name of the technical school or college and the name of the winning student.
